

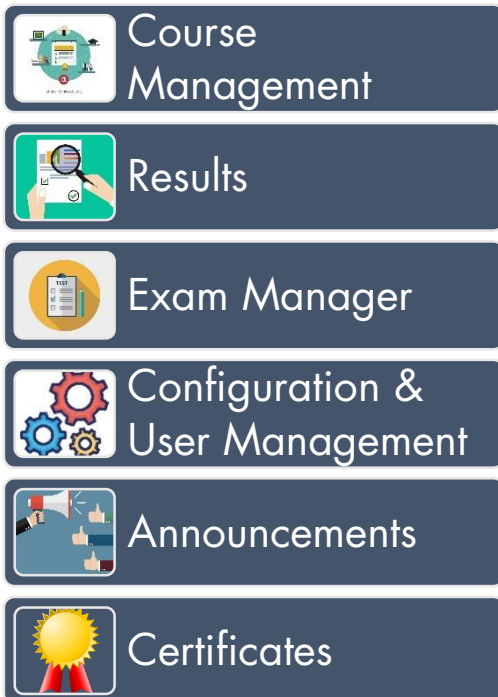

Create Courses

Course Outline such as Title, Description, any pre-requisite courses etc. is inserted to provide a brief introduction to the trainee. In Basic Information Tab, user can upload Course Banner picture and drag and drop Promo videos to engage the audience.

Limit the number of attempts & set the level of competency to select the right audience. You can also add sections and make multiple units under the same section.

Upload Question Bank

You can add your questions using the built-in support for Microsoft Excel from external source with just a few clicks.

Multiple choices

Multiple choices and true/false questions can be scored instantly. Answers are graded automatically - the responses can also be e-mailed to the recipients.

Quizzes

Create Quizzes and add questions as required. The questions will be generated randomly and will create a customized questionnaire for each Business Title, making it easy for the examiner to set the difficulty levels for each hierarchy level. You can create training assessments, educational quizzes, psychological or personality tests, surveys etc.

Questions will be generated randomly making sure that every participant gets a unique test. Multiple choice questions functionality is available in application. Certain parameters can be set for each test. These parameters include:

- a) Time-limit
- b) Passing percentage
- c) Open / Closed approach to training material
- d) Feedback

The system also allows to select questions manually as well as automatically on basis of difficulty level.

Design Course Outline

Exams

Exam Tab consists of multiple features and appearance of screen depends upon the rights allocated to a particular profile. Each employee attempting an exam can view the assigned tests here.

The examiner can select Quizzes or Courses and assign to employee(s). Selection can be made easily according to departments or designations. User can allocate the exam to employees by selecting course status or by using optional filters available for the ease.

Level & Hierarchies

Based on the hierarchies in an organization, the system allows you to make as many levels as required. These can be made at three different levels which include entity, division and department

Scheduling Training Sessions

Results

Results can be automatically graded and scored by the system. Trainees can see their scores immediately after taking the test, which can also be reported later by the trainer. Different results can be displayed for different departments and the results can be displayed according to the tests as well.

Reports

A simplified view of the overall performance of employees can be generated via reports. Managers and administrators can review grades and scores on the basis of department, hierarchy level etc.. Each quiz (i.e. the answers given by test takers) can be later displayed on-screen, printed or exported to a PDF file.

Profile

Profile function enables the system administrator to create different user profiles with different privileges and manage rights for each one of them. These user profiles define roles of all the users into the system which maps the workflow. A user when given rights to a page can access its full functionality.

User profiles are allocated as per the policy of the organization. Profiles are fully configurable and user can create as many profiles as required by the organization.

User can Edit, Delete or Copy Courses according to the rights allocated to that particular profile.
